Broward Healthy Start Coalition, Inc., (Coalition) is a nonprofit 501(c) 3 corporation located in Fort Lauderdale, FL that leads a cooperative community effort to reduce infant mortality and improve the health of children, childbearing women and their families in Broward County. We are seeking an RN to perform Model Behavior services for the Safe Sleep Program.

OVERVIEW OF DUTIES

The RN Model Behavior Consultant will conduct the Model Behavior services for Broward Healthy Start's Safe Sleep Program in Broward County as follows:

- a. Work collaboratively with the Safe Sleep Program Manager, and FIMR Program Manager as needed, on the Safe Sleep Program and Model Behavior implementation.
- b. Actively work to re-introduce and or implement Model Behavior to the medical community and hospitals. Provide Model Behavior training on infant safe sleep practices to maternity and neonatal nurses and other healthcare providers in the five (5) hospitals in the north end of the county including Broward Health Medical Center, Plantation General Hospital, Coral Springs Medical Center, Holy Cross Medical Center, and Northwest Medical Center.
- c. Promote and facilitate one standing, monthly community training open to staff from assigned hospitals and nearby medical offices with the goal of educating a minimum of 100 healthcare providers and/or staff during the year. These trainings will include pre/post tests, sign-in sheets, and a presentation including the 19 Safe Sleep Recommendations of the American Academy of Pediatrics and information about the Safe Sleep Cribs Program at BHSC and how to refer families.
- d. Monitor and follow up on Safe Sleep implementation of Model Behavior and compliance at assigned hospitals. Assist with any Safe Sleep Program related audits to take place at assigned hospitals.
- e. Assist with the certification process of each of the assigned hospitals to meet the requirements of the Cribs for Kids Safe Sleep Hospital Certification Program.
- f. Participate in monthly meetings, or more frequently as needed, with the Safe Sleep Program Manager.
- g. Implement the local Safe Sleep Certification Program into Pediatrician and OB offices
- h. Participate in monthly Safe Sleep Committee meetings when available, or at the request of the Program Manager.
- i. Facilitate the Safe Sleep Healthcare Subcommittee Meeting as a co-chair once a month. This meeting will highlight the progress of the Model Behavior Program as well as introduce new initiatives to spread the safe sleep message within the medical community.
- j. Document all trainings and follow-up on forms and in the method agreed upon with the Coalition

This is an independent consultant role for approximately 12 to 15 hours per month with a reimbursement rate of \$55/hour. Requires Bachelor's degree in nursing with an active RN license and a minimum of five (5) years clinical experience in labor and delivery, NICU, and/or maternal and child health.
